- Non-registered (Commercial) females each with a calf: the cows must be 48 months of age and the Calves be one month old.
- The animal must have been owned by a person who had continuous title to such animal for a period of at least 90 days immediately before acquisition by the purchaser or in cases where multiple herds are being used to make up the required numbers the seller must indicate such animals and the previous owner must have had them for the stipulated timeframe. Health and breeding records for such animals must be made available and attest that they originate from a clean herd.

- The animal must, at the time of purchase, be individually identified by an eartag, a legible ear tattoo, or a firebrand as prescribed by "AI Act, 2002"
- Non-registered animal" means an eligible animal, whether or not purebred, which is predominately of the colour characteristics and body conformation of the beef breed stated in the acceptable breed description.
- Estimated Breeding Values (EBVs) preferably high EBVs for growth and mature cow weight should be supplied (if available)

### **General Requirements for Females and Males**

#### **Health Certificate**

- Health Certificate issued or endorsed by Veterinary Services, Animal Health Inspection Service, listing the identification number (s) and showing that such animal has been inspected for compliance with " Health " requirements.
- According to the **Animal Disease Act 35 of 1984**, the focus is on TB and Contagious Abortion (CA) status – by testing prior to purchase (on owners' farm) or isolate and test on arrival on the buyer's farm. Positive animals must be culled.

#### **A. Health**

- Tested negative for brucellosis within 30 days Prior to Delivery to the new owner or is an official vaccinate under 30 months of age. (No animals will be accepted from a brucellosis positive herd even if they themselves have tested negative)
- Animals come from farms that have not been under State quarantine for any communicable disease during the past year (especially FMD zones)
- Animals have been inspected, and found sound (including freedom from blindness, structural defects), free of evidence of communicable disease and exposure thereto, and free of mites, ticks and ringworm.
- Semen check indicating at least 60 % sperm motility for bulls over 12 months.
- Copy of the Bull Registration certificate with the breed association.
- No bull of similar or close pedigree to be supplied with breeding females on one farm.
- External parasites to be treated at farm of origin two weeks before departure

### **Transportation**

- Transportation must be appropriate for the class of animals and must minimize effecting stress on the animals.
- The supplier must ensure that he quotes for the appropriate transport and only one trip will be paid for.
- All animals will be inspected at farm of origin by officials of the department before departure

- ***The transporter must have relevant insurance to cover any potential loss that emanate from collection and drop off.***

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

**1. DEFINITIONS**

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of tender invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions;
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (f) **“Historically Disadvantaged individuals”** means a person historically disadvantaged by unfair discrimination on the basis of race: Provided that a person historically disadvantaged on the basis of race refers to Africans, Coloureds, Indians and people of Chinese descent who are South African citizens by birth or descent; or who became citizens of the Republic of South Africa by Naturalisation -
  - Before 27 April 1994; or
  - On or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalization prior to that date.

## 2. GENERAL CONDITIONS

2.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and

### 2.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- b) 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

2.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

### 2.4 To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

2.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

2.6 Tenderers that fail to claim points for specific goals or that fail to fully complete the table in paragraph 2.12 below, will not be awarded points for specific goals.

2.7 Tenderers that make a calculation error when claiming points as per the table in paragraph 2.12 below, will not be awarded points for specific goals. Please take note of the examples on how to calculate points for specific goals as per paragraph 2.12 below.

2.8 Tenderers that fail to submit the correct SBD 6.1 form as issued by the Department of Agriculture, Land Reform and Rural Development, will not be awarded points for specific goals.

2.9 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2.10 Tenderers who wish to claim points in terms of the table in paragraph 2.12 below need to provide proof for each point claimed as guided below:

2.10.1 Historically Disadvantaged individuals (HDI):

- **Attach a copy of Identity Document (ID) and company registration document.**

2.10.2 Who is female:

- **Attach a copy of Identity Document (ID) and company registration document.**

2.10.3 Who has a disability:

- **Attach a certified copy or original doctor's letter confirming the disability.**

2.10.4 Who is youth (a person that is not older than 35 years on the closing date of a bid):

- **Attach a copy of Identity Document (ID) and company registration document.**

2.11 The Department will use the Central Supplier Database and documents submitted by the tenderer to verify the points claimed for specific goals.

2.12 **Specific goals for the tender and points claimed are indicated per the table below.**

The number of points claimed for specific goals, are calculated as follow:

  - **Percentage ownership equity** x 10 ÷ 100 = number of points claimed.
- (II) A maximum of 5 points may be allocated for to tenderers who is female, on the following basis:
  - **Percentage ownership equity** x 5 ÷ 100 = number of points claimed.
- (III) A maximum of 2 points may be allocated to tenderers who has a disability, on the following basis:
  - **Percentage ownership equity** x 2 ÷ 100 = number of points claimed.
- (IV) A maximum of 3 points may be allocated to tenderers who are youth, on the following basis:
  - **Percentage ownership equity** x 3 ÷ 100 = number of points claimed.

**2.13 It is important to note that failure by a tenderer to complete the table in paragraph 2.12 in full, will result in points for specific goals not to be allocated.**

### **3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES**

#### **3.1. POINTS AWARDED FOR PRICE**

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in the table in paragraph 2.12 above as may be supported by proof/documentation stated in the conditions of this tender.
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
  - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
