PROTECTION OF LAND RIGHTS ACT 31 OF 1996**

In terms of section 5 (2) of the Interim Protection of Land Rights Act, 1996 (Act No 31 of 1996) ("the Act") the Minister of Agriculture, Land Reform and Rural Development may, by notice in Government Gazette, extend the application of the provisions of the Act; and table such notice in Parliament.

In accordance therewith, the Government Notice providing for the extension of the application of the provisions of the Act until 31 December 2024 is hereby submitted to Parliament for tabling.
